This will allow the audio from the customer provided PC to be heard over the sound system. It will also allow the audio from the room system to be heard by the far side participants on the Zoom call. Provide and install QTY 2 PTZ Optics PTZ cameras and mounts installed on the ceiling to provide video shots of the council chambers participants in Zoom meetings. The cameras will be cabled back to the owner furnished PC. A multi-viewer processor will be used to provide a split screen camera shot of the council chambers for the far side Zoom participants. Control of the cameras is via the included handheld remote controls. Provide the following:

We hereby propose the following: Provide the labor and materials to provide USB audio integration for a customer provided PC running Zoom with the council chambers audio/video system. This will allow the audio from the customer provided PC to be heard over the sound system. It will also allow the audio from the room system to be heard by the far side participants on the Zoom call. Provide and install QTY 11 push to talk microphone bases to replace the existing microphone bases. Provide and install QTY 1 PTZ Optics PTZ camera and mount installed on the ceiling to provide a wide video shot of the council chambers participants in Zoom meetings. Provide and install QTY 7 fixed HDMI cameras with individual video monitors for the council member's locations. The cameras will be cabled back to the owner furnished PC. A switcher and video distribution amplifier will be installed for the cameras. When a user presses the push to talk microphone button the system will switch the video to the individual camera located in front of the participant and send that video feed to the Zoom PC. At the same time the camera feed will show up on the individual video monitors located on the Dias and the projection system. Cable will need to be installed from the new camera locations to the owner furnished Zoom PC. Cable will need to be installed between the audio/video system equipment rack and the microphone locations. Provide the following:
