Josh Collins, Coalition Against Bigger Trucks (CABT), answered whether 33-foot trailers fit on a rail car and stated they will be able to fit but the rail cars will only be able to accommodate one of them.

Collins answered whether CABT is the same group as the 2001 Washington Alliance for Safe Highways (WASH) noted in the minutes excerpt on file, where this is going on a Federal level and whether a letter from the Council will make a difference.
