Eric Richey, Whatcom County Prosecuting Attorney, reported and answered which staff position posting received 17 applicants, whether trial dates are increasing or whether there are still bottlenecks for trial dates due to COVID-19, and whether drug court numbers may be down due to a lack of support groups because of the pandemic.
