Byrd stated he would like to move to approve \$250,000 to be dedicated to

waste disposal for the community (related to the flood).

Councilmembers and Schroeder discussed whether the committee has authority to make such a motion, whether it might be better to discuss this and make a motion in Committee of the Whole, adding organizations - government partnerships to the rubrics in the Natural Hazards Mitigation Plan, making sure they are thinking about areas such as Deming that do not have representation other than the County, when they will hear more about the flood response and the agenda items associated with the Natural Hazards Mitigation Plan, and whether people can move back into their houses without going through a full permitting process.
