Ann Beck, Health Department, briefed the Councilmembers and she and Lautenbach answered questions about whether these emergency shelters are for people who are unwilling or uncomfortable or maybe do not meet the qualifications to go to some of the other shelters that we also have set up and also pay for, the criteria for activating the warming shelters, whether there should be buy-in from the guests and a process to earn the use of the shelter, how people would go back and forth between the Bellingham Public Library during the day and Depot Market Square for the night, whether the City of Bellingham has already approved the agreement, whether it would make sense to extend the use of Depot Market Square so people do not have to be moved back and forth, what happens if the weather drops with less notice than the two-days-in-advance criterion for going operational, and how many people would use the shelter at one time.
