 Presentation from Portage Bay Shellfish Protection District Advisory Committee and Public Works staff regarding status of shellfish recovery plan

> Erika Douglas, Public Works Department, gave a presentation (on file) and answered what the time scale was for the improvements in water quality at 76 percent of the fresh water stations, whether the County has a partnership with Blaine for working with stormwater as it does with Ferndale and Lynden, whether there was any discussion about merging the shellfish advisory committees (Portage Bay and Drayton Harbor) with Birch Bay Watershed and Aquatic Resources Management (BBWARM) so there is just one group, whether the Drayton Harbor Shellfish Protection District will sunset at the same time as the Portage Bay Shellfish Protection District, whether other types of closures (like biotoxin closures) were included in the closure data presented or whether those types of closures are separate, whether there could be overlap between the fecal closures and the biotoxin closures in the data, and whether our detection is getting better to be able to tell human fecal matter from cow fecal matter.
